### **Privacy Policy**

#### JACK RICHARDS AND SON AND SON INTERNET SITE PRIVACY POLICY

This website is owned and operated by Jack Richards and Son ("Jack Richards and Son", "our", "we" or "us"). "Jack Richards and Son" is the controller of all personal information collected on this website. We believe strongly in protecting the privacy of all website users ("you", "yours") and this notice sets out how we use your personal data. By registering on this website or otherwise, you consent to the collection, use and transfer of your personal information under the terms of this privacy policy.

## What data ("personal information") do we gather from you?

We gather personal information such as first and last names, business addresses and email addresses that you provide voluntarily when you fill in appropriate sections of our website. For example when you complete our respective purchasing and selling forms in order to enquire about products you wish to purchase or sell, and when you request details of our products and services, you provide us with personal information which we hold and use for the purposes set out in the next section.

#### Use of your personal information

#### Sharing of personal information

We may share personal information within the Jack Richards and Son family ("Jack Richards and Son"); by this expression, we mean the Jack Richards and Son group and each and any of its subsidiaries, together with their respective officers, employees, agents, distributors, consultants, suppliers and certain selected companies. The Jack Richards and Son Family will process your personal information in accordance with this privacy policy and all privacy and communications legislation

Those selected companies are either our partners who perform a function relating to our purchasing, selling, promotions and/or offers, or are agencies and suppliers whom we have retained to assist us to more effectively fulfil orders, manage and conduct our business generally, provide technical assistance and support and perform other functions to support our marketing activities.
